

GENERAL TERMS AND RULES OF USE:

Only the persons who accepted the General terms and signed the Liability Waver Consent (hereinafter the Consent) are allowed to use the go-kart track. Every user of the services provided by Autokomerc Karting Centar shall adhere to the stipulated general terms and rules of use of Autokomerc Karting Centar to ensure safety of all participants at the go-kart track and around it.

GENERAL TERMS:

- You shall use the karting center, enter the complex, facility and go-kart track, stay there, participate in the activities taking place there at your own responsibility and at your own risk.
- Only the persons who accepted the General terms and signed the Consent, which is a prerequisite for using it, shall be allowed to use the go-kart track
- You may use the go-kart track only during working hours, subject to availability
- Minors may use the go-kart track only when one of the parents or a guardian fills out and signs the Consent
- There are certain age and height limits when it comes to using the go-kart track, namely:
 - children under the age of 7 may not use the go-kart track
 - karting for kids (junior karting): must be at least 7 years old and 135 cm tall,
 - adult karting: 12 years old and 160 cm tall
 - in certain cases when the child's age is appropriate for junior karting and his/her height is appropriate for adult karting, the Autokomerc Karting Centar staff may make a decision to approve the use of the go-kart for adult karting
 - persons who are old and tall enough to use the go-kart for adult karting may not use the go-kart for children
- If you use a go-kart for two people (a two-seater go-kart) and one of the persons is a minor then the driver must be a parent/guardian or another adult with an approval signed by a parent/guardian
- You must, without exceptions, follow the instructions of the staff when using the go-kart track
- The use of go-kart track requires a high level of attention, physical fitness and discipline of the user. Only persons who have no physical limitations which could affect safe driving may use it. We draw special attention to the increased risk for people who have heart problems, spine and neck problems or suffer from high blood pressure.
- Pregnant women may not use the go-kart track
- Driving a go-kart under the influence of alcohol, narcotics, drugs or other psychoactive substances is forbidden.
- Driving a go-kart carries the risk of injury, which cannot be ruled out even if the rules of use are followed. Go-karts do not have seat belts or air bags. A go-kart acts differently than a passenger vehicle and the steering is harder and more direct. It must be driven carefully, the speed must be adapted to the track conditions and collisions with other participants in the session as well as safety fences must be avoided.
- For damage caused through the user's own fault, either due to an accident, improper use or because they did not follow the instructions of the staff, the go-kart driver (parent/guardian for a minor) assumes unlimited responsibility.
- Autokomerc Karting Centar shall not assume responsibility for the damage incurred by using a rented go-kart caused by a user of another go-kart.
- Minors must be supervised by a parent/guardian or person accompanying them during their entire stay in the karting center and its surroundings.



RULES OF USING THE GO-KART TRACK:

All users of the go-kart track who accepted the General terms and signed the Consent are obliged to adhere to the following rules:

- Follow the instructions of the employees of Autokomerc Karting Centar. The user who, during the drive, acts contrary to the General Terms and Rules of Use of Autokomerc Karting Centar shall be removed from the track immediately without a right to refund. The authorized person of Autokomerc Karting Centar shall reserve the right to refuse renting a go-kart and deny access to the track to any person who jeopardizes his/her own safety or that of others at the go-kart track and around it.
- The left pedal in a kart is the break and the right one is the gas. It is strictly forbidden to press the gas and the break at the same time.
- When using the go-kart track, the driver must be considerate at all times and follow the light signals, flags, direction and follow the instructions of the employees of Autokomerc Karting Centar without exceptions.
- It is strictly forbidden to stay or walk near the pit stop or the go-kart track.
- During the session, you must drive a go-kart in a way in which it does not put other drivers at the go-kart track in danger. Pushing, driving right next to another person to push them off the track, hitting, as well as any other kind of reckless and inappropriate behavior is forbidden, and a person who violates the General terms in this way will be immediately removed from the track.
- The driving must be adjusted to the conditions on the track. In order to get used to the track the driver should drive the first few laps at a slower pace. Given that the go-kart track is located in an open area, it is exposed to changing conditions due to the weather, as a result of which the speed of the vehicle must be adjusted adequately.
- Upon giving the signal for the end of the drive and before entering the pit, the driver must slow the go-kart down to the minimum possible speed (walking speed) and slowly and carefully enter the pit. The driver may not leave the go-kart until all the go-karts are in the pit or until the operator gives the permission to leave the go-kart.
- If during the drive you happen to go off track or you stop due to a technical issue or a malfunction, you must stay in the go-kart and raise your hand so that a staff member could come and help you. It is strictly forbidden to leave the go-kart, take off your helmet or drive in the opposite direction
- Leaving the go-kart during the drive is strictly forbidden
- Certain parts of the engine are hot therefore you may not, at any moment, lean on the engine, exhaust pipe, rotating parts of the go-kart when entering or leaving the go-kart.
- The participants must use the protective equipment. This includes wearing a full-face helmet in compliance with ECE regulation no. 22 for motor vehicles. When using the rental helmets, you must use the balaclava for hygienic reasons
- The clothes you wear in a go-kart should be tight. The shoes should be comfortable and flat. For safety reasons you should not wear any shawls, scarves, wraps, ties, longer necklaces or similar accessories. Driving in long, wide skirts as well as wearing slippers, flip flops or heels when driving is forbidden. Autokomerc Karting Centar shall not be responsible for the damaged clothes, footwear or accessories of the user.
- If you have long hair it should be tied up into a ponytail and tucked under the balaclava.
- The participants are responsible for the proper use of the protective equipment and the correct position in the seat which mainly means whether they can reach the steering wheel and the pedals.
- Carrying anything that may fall onto the track (cellphone, keys, etc.) is strictly forbidden. Cellphones, keys, wallets, etc. may not be kept in the pockets of the trousers since they might fall out during the drive. You can lock them in the lockers which are available to you or keep them in the zipped pockets of the upper clothing items. Autokomerc Karting Centar shall not be responsible for any damages or loss of your belongings.
- If there are any doubts and/or questions about the rules of conduct, the users may not start their drive.



CONSENT:

The participant confirms that he/she is familiar with the rules of conduct and general terms at the go-kart track and by personally signing this consent, he/she accepts and assume **ALL RESPONSIBILITY** for any potential injuries that may occur at the karting track and around it.

The participant must pay for any damage caused to the vehicle, whether the damage was caused by improper use of the vehicle, running off the track or due to the contact with other karting vehicles. Any abuse of the vehicle shall not be tolerated.

MINOR PARTICIPANTS
1. If the participant is a minor and he/she is accompanied by his/her parent or guardian, his/her
parent or a guardian must sign the consent to use the go-kart and to drive at the go-kart track.
I hereby agree, as a parent/guardian of the minor (full name and surname in block letters):
that he/she may use the go-kart and take part in driving at the go-kart track and by personally signing this form I accept and assume all RESPONSIBILITY for any potential injuries of the minor or damages caused by the minor which may occur at the go-kart track and around it.
2. If the user is a minor and he/she is accompanied by a third person (grandmother, grandfather, a relative, etc.) the companion must deliver the consent given by a parent or a guardian to use the go-kart and to drive at the go-kart track.
I hereby agree as a parent/guardian of the minor:
accompanied by (name and surname) may use the go-kart and take part in driving at the go-kart track and by personally signing this form I accept and assume all RESPONSIBILITY for any potential injuries of the minor or damages caused by the minor which may occur at the go-kart track and around it.
3. <u>Organized visit of MINOR participants</u> If the minors arrive accompanied by an adult in the form of an organized visit, the adult (the organizer) shall personally sign this form to confirm that the minors:
were entrusted to him/her by their parent or guardian and he/she shall bring the consent given by a parent or a guardian individually for each minor whose parent or guardian agreed that he/she may use the go-kart and take part in the drive at the go-kart track which they personally signed and thereby accepted and assumed all RESPONSIBILITY for any potential injuries of the minor or damages caused by the minor which may occur at the go-kart track and around it.
